Objective:

Atal Pension Yojana (APY), launched on 9th May, 2015. It is a pension scheme for citizens of India is focused on the unorganized sector workers. This scheme is administered by the Pension Fund Regulatory and Development Authority (PFRDA).

Under the APY, guaranteed minimum pension of Rs. 1,000/- or 2,000/- or 3,000/- or 4,000 or 5,000/- per month will be given at the age of 60 years depending on the contributions by the subscribers.

Pension provides people with a monthly income when they are no longer earning. Any Citizen of India can join APY scheme.



7. After submitting the personal and Nominee details, Citizen is redirected to NSDL website

for eSign.

8. Further it will ask for Aadhaar verification and send OTP. Once verified, Citizen gets successfully registered in APY.

The Government of India has made Sukanya Samriddhi Yojana accessible for everyone, and hence, you can open an account at any post office.

1. Just parents or legitimate guardians of the girl child.
2. The girl child ought to be less than 10 years at the time of account opening. The account can be operational till the girl child is 21 years old.
3. The opening investment can begin from ₹250 and a limit of ₹150000.
4. An individual girl child cannot have numerous Sukanya Samriddhi accounts.
5. She should be a resident citizen of India
6. Account cannot be opened for more than two girl children in a single family. Provided in case of twins/triplets girls birth more than two accounts can be opened.

Step by Step Process to open a Sukanya Samriddhi account?

You can open a Sukanya Samriddhi account via an authorised bank branch or a post office.

1. To open a Sukanya Samriddhi account at a bank branch

In order to open an account through a bank, simply follow the following steps:

- **Step 1:** Visit the nearest branch of an authorised bank.
- **Step 2:** Fill out the Sukanya Samriddhi account form with the required details.
- **Step 3:** Provide supporting documents. These documents include the following:
 - Identity proof of the parent or legal guardian of the girl child
 - Proof of residence of the parent or legal guardian
 - Photograph of the parent/legal guardian
 - Birth certificate of the child

 - Begin filling up this form by entering the post office branch name.
 - Mention the corresponding account number if you already have a savings account with this post office.
 - Name the post office branch as well as postal address details under the option 'To the Postmaster.'
 - On the right, paste the applicant's photograph.
 - Now, you will find an option named 'I/We.' Here, enter the name of the applicant and mention 'Sukanya Samridhhi Yojana' in the following space.
 - You need to skip the content box as it is only applicable for opening a PO savings account.

World's largest **DBT** (Direct Benefit Transfer) scheme for farmers

A central sector scheme called **Pradhan Mantri Kisan Samman Nidhi (PM-KISAN)** promises to give financial support to all farmer families in the nation who own cultivable land, subject to specified exclusions. The Scheme involves direct deposits of Rs. 6000/-a year, divided into three equal instalments of Rs.2000/- each. All landholder farmers are eligible for this scheme. They or any of their family members should not be a taxpayer in the previous assessment year. The agricultural land should be strictly used for farming purposes. Following the release of the payment by the authorities, applicants get Rs 2,000 in their bank accounts once per quarter (**August-November, April-July and December-March**). The scheme aims to provide income support to all landholding farmers' families by supplementing their financial needs while procuring various inputs to ensure proper crop health and appropriate yields, as well as their domestic needs.

Eligibility:

- a) Under Pradhan Mantri Kisan Samman Nidhi Yojana, the government provides income support of Rs 6,000 per year to all farmer families **who have their own cultivable land registered in their name, regardless of the size of the landholdings.**
- b) Your Aadhaar will be authenticated with UIDAI. You will be able to proceed for registration only if your Aadhaar is authenticated.
- c) KYC is mandatory for Bank transactions.

Documents Required:

- a) Aadhaar Card link to Mobile
- b) Landholding Papers (7-12 Registration, Map of Farm Land)
- c) Citizenship Certificate (Ration Card)
- d) Bank Account Details (Bank Passbook)
- e) Valid Mobile Number

Procedure

Step-1: open the PM Kisan Samman Nidhi Yojana, either by using official website <https://pmkisan.gov.in/> through browser OR by Downloading the **PM Kisan Mobile App**.

Step -2: Go to the farmer's corner available on the home page of the website itself.

Step -3: Click on the **New Farmer Registration** , you will get first page of registration form showing Aadhar card number and valid mobile number, enter the correct information, after that fill the exact captcha , you will two OTPs on your mobile number, first is for PMKISAN and second one is for Aadhar UIDAI

Step -4: After entering the correct OTPs click on **Continue** button, you will another **Persona Details Page** where you have to fill all your personal details such as your name, fathers

name, address, gender, caste etc. as well as your farmland details such as Taluka where your farmland is , area of the farmland in hectares, khasra no. etc.

Step -5: After filling all the personal information, click on SUBMIT button, you will get the message “**Registration is Successful**” .

In this way the Registration process of PM Kisan Samman Nidhi Yojana is carried out.
