Following points were discussed in the meeting.

1. Dr. Mrs. S. A. Bhide assigned the task of taking satisfaction survey for students, teaching and non-teaching staff to Priyanka Samarth and Deepali Bhende. Then obtain Satisfaction Score of every stake holder.

2. Santosh Shahu was asked to speed-up the valuation process so that results can be declared sooner.

3. The chair asked Santosh Shahu, Nisha Vyas , Deepali Bhende and Chaitanya Pipalwa to ensure that the pass percentage escalates for subjects with low outcomes.

4. The chair also suggested giving repeated assignments especially for the Killer subjects like Economics as well as Financial Accounting (Commerce Stream) and Discrete Mathematics plus Operational Research (Computer Science Stream). Also the students must write answers 5 times for getting memorized easily.

5. To reduce the menace caused by students who do not attend the classes regularly but are present in the college premises, some strict action must be taken. Parents of such students must be called and informed about the misbehavior of their child.
6. All Final year Mentors were asked to keep track of students for at least one year after graduation.
7. The Director also told all the HODs to counsel students for future prospects for Higher education by conducting at least two meetings one in Feb and one in April.
8. Subject wise remedial classes must be taken by all subject teachers.
